TERMS & CONDITIONS:

1. Information on how to enter forms part of these Conditions of Entry. Entry into this Promotion is deemed to be an acceptance of all Conditions of Entry.

'Win a Custom-made Surfboard' competition is a collaboration between Bosch and Verdure Surf, whereby the two winning entrants will each be awarded one custom-made surfboard from Verdure, Lyall Bay, Wellington, New Zealand (custom-surfboard conditions apply – see point 8). One winner within Australia and one winner within New Zealand.
3. The casting call entry commences at 4:00pm (AEST) on Tuesday the 1st of November 2022 and concludes at 11.59pm (AEST) on Sunday the 13th of November 2022 (Casting Call Period).
The top two participants, one from Australia and one from New Zealand, will then be contacted directly via email (from a Bosch Professional Power Tools email account only) between Monday 14th November 2022 and Friday 18th November 2022 (winner selection period), to inform them they have successfully been selected to receive a custom-made Verdure surfboard (prize).
4. Entry is open to tradespeople of Australia and New Zealand aged 18 years and over, who submit a valid entry within the Casting Call Period in accordance with these Conditions of Entry. Employees and their immediate families of the Robert Bosch (Australia) Pty Ltd ('The Promoter'), its related entities and associated companies, agencies, suppliers, retailers or companies associated with this Promotion are ineligible to enter.
5. To be eligible to enter, entrants must:

 - b. All entrants must answer the following question: "*Surfboard shaper, Jack, at Verdure says that Bosch's 18V Power Tools are the final piece of the puzzle in sculpting the perfect surfboard. **In 30 words or less, tell us what makes a perfect surf for you?***"
 - c. All entrants are required to provide all mandatory information/fields via the sign-up form.
6. Entrants are eligible to submit once during the Casting Call Period. All competition entries will be judged against each other, the two entries deemed most original by the Promoter will be selected to be sent the product for testing and review.
7. The decision of the Promoter is final and no discussion will be drawn into.
8. Each of the two shortlisted Winners will receive one of the following products:
 - Custom made surfboard valued up to the value of \$2,300 (NZD)
 - Verdure Surf's 'Logs boards' are excluded from the custom-board choice list for this competition prize(s)Total prize pack is valued at \$4,600 NZD

9. All entries become the property of the Promoter. All entrants agree to their entries and Instagram, Facebook and/or YouTube profile names being published on the Bosch Power Tools Australia and New Zealand Facebook page, by the Promoter in the Promoter's sole discretion, during and after the Promotional Period.
10. The testers are required to write an objective, informative, reasonably extensive and unbiased product review immediately, but at the latest within one month after receipt of the test item, and shall then publish this review on his/her social media profile (Instagram and/or Facebook). Depending on the medium (test article and/or video), the following supplement shall be included right at the start of the article: "advertising" or "advertising video". When testing the test product and writing the product review, the tester shall observe the operating instructions relating to the test product, including but not limited to requirements for personal protective equipment. If the tester does not comply with these regulations and Bosch becomes aware of this, the tester shall be obliged to delete the article immediately at the request of Bosch. Reviews must not contain offensive or defamatory comments or images, or comments or images which breach any law or infringe any third-party rights, including intellectual property rights
11. Bosch will have the free exclusive right (including the right of editing, e.g. through abridgements, changes in the formatting, production of extracts) to publish the test reports both on external and internal media, including on the Internet (including social media) and in Bosch's own media.

13. The Promoter reserves the right to verify the validity of all entries and to disqualify any entrant who interferes with or fails to comply with the correct entry process, or who submits an entry which is not in accordance with these Conditions of Entry.

The Promoter accepts no responsibility for any entries that are lost, late, misdirected or not received by the Promoter within the Promotional Period or for any delays in the delivery of entries due to technical disruptions or for any other reason.

Entries containing offensive or defamatory comments or images, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win (and will be removed from the Bosch Power Tools Australia and New Zealand Facebook page).
